

# Tangible Personal Property Tax Assessments

Every person who owns or holds tangible personal property, shall annually list said property for assessment with the County Appraiser. 2021 Tax Year Personal Property Assessment forms have been mailed to Franklin County residents. Assessment forms are used to claim oil/gas properties and personal property – including heavy trucks.

Residents should return forms no later than March 15, 2021. Forms can be mailed to:

Forms can also be returned at the courthouse to the Appraiser's office. Every personal property owner shall return a signed form, regardless of changes. A signature reflects certification that the list and/or changes listed are true and correct.

## What Qualifies as Tangible Personal Property?

Tangible personal property is a tax term describing personal property that can be physically relocated. Examples include; mobile homes, motor vehicles that are not taxed at time of registration, marine equipment and motors, miscellaneous vehicles such as golf carts, ATVs, and miscellaneous trailers, etc.
