A RESOLUTION TO VACATE A PORTION OF OSBORNE LANE IN FRANKLIN COUNTY, KANSAS

WHEREAS, the Franklin County Commission authorized notice of proposed vacation of a portion of Osborne Lane beginning at the intersection of the east right-of-way line of Louisiana Terrace and the centerline of Osborne Lane in Section 27, Township 16S, Range 19E., of the Sixth Principle Meridian, thence northeasterly and easterly along said centerline to the Southwest corner of the East one-half of the Northwest quarter of Section 26, Township 16S, Range 19E, in Franklin County, Kansas; and,

WHEREAS, the Notice of Public Hearing was published in the official county newspaper on June 21, 2014 and

WHEREAS, notice of the proposed vacation was mailed by certified mail, return receipt requested, to all landowners of record as required by K.S.A. 68-102 notifying said landowners of the intent to vacate a certain portion of the road, and of their right to protest said vacation; and,

WHEREAS, a hearing was held on June 25, 2014, for anyone wishing to protest the vacation of said particular road; and,

WHEREAS, as a result of that hearing, the Franklin County Commission voted to vacate a certain portion of the road.


THE BOARD OF COUNTY COMMISSIONERS OF FRANKLIN COUNTY:

That the following road is not a public utility by reason of neglect, non-use, or inconvenience and that said road has become practically impassable and the necessity for said road as a public utility does not justify the expenditure of the necessary funds to repair said road or put the same in condition for public travel and therefore a portion of said road is hereby vacated as follows:

Osborne Lane beginning at the intersection of the east right-of-way line of Louisiana Terrace and the centerline of Osborne Lane in Section 27, Township 16S, Range 19E., of the Sixth Principle Meridian, thence northeasterly and easterly along said centerline to the Southwest corner of the East one-half of the Northwest quarter of Section 26, Township 16S, Range 19E, in Franklin County, Kansas; and,

This Resolution shall be in full force and effect following its passage by the Board of County Commissioners and its subsequent publication in the official county newspaper.

WHEREUPON, the Board of County Commissioners of Franklin County, Kansas, passes and adopts this Resolution in regular session, at its chambers in Ottawa, Franklin County, Kansas, this 25th day of June, 2014.
