**NOTICE OF SPECIAL QUESTION ELECTION  
UNIFIED SCHOOL DISTRICT NO. 368,  
MIAMI COUNTY, KANSAS (PAOLA)**

The Board of Education of Unified School District No. 368, Miami County, Kansas (Paola) (the “District”), has heretofore, pursuant to resolution duly adopted, declared it advisable to levy a tax on the taxable tangible property within the District for the purpose of financing the costs incurred by the State of Kansas that are attributable directly to assignment of the cost-of-living weighting to the enrollment of the District pursuant to K.S.A. 72-5159. Notice is hereby given to the qualified electors of the District that a special question election has been called and will be held on November 4, 2025, for the purpose of submitting to the qualified electors of the District the following proposition:

Shall the following be adopted?

Shall Unified School District No. 368, Miami County, Kansas (Paola) (the “District”) be authorized to levy an ad valorem tax in an amount not to exceed the amount necessary to finance the costs attributable directly to the assignment of cost-of-living weighting to the enrollment of the District, pursuant to the provisions of K.S.A. 72-5159?

To vote in favor of any question submitted on this ballot, press the word “Yes” on the voting machine or completely darken the oval to the left of the word “Yes” on the paper ballot. To vote against it, press the word “No” on the voting machine or completely darken the oval to the left of the word “No” on the paper ballot.
